
NARCAN[®] Nasal Spray and Opioid Epidemic Perceptions Survey





They interviewed 1,005 American adults online between April 24 through April 28, 2024. The survey was designed to be representative of the American adult population a whole by age, gender, region and HHI (+/-3%). Aggregate data wastested for statistical significance at the 95% confidence level. Data on file.








































